

Dear Cass School District 63 Parents,

As we continue to work on the details of our framework for starting the 2020-21 school year, I would like to share with you some other important information. *Reimagining School: The Cass 63 Return to Learn Framework* will be rolling out this week, but we know how critical some of these programs are to our children, parents and families, as well as all of us here in the school district. No decision is taken lightly, but I feel that we have an obligation to share this with you now so that you can plan accordingly.

It is with great regret that I inform you that we will not be able to offer the Before and After School Experience (BASE) program to start the 2020-21 school year. We will not rule out the possibility of this coming back later in the school year, depending on health conditions and guidelines at the time, as well as our ability to staff the program. While I realize this announcement does not impact all families, we take this very seriously for the ones that it does and we wanted to let you know this in advance.

Unfortunately, there is no path to offering BASE at this time while also ensuring the safety of your children and our staff. By its nature, the BASE program is very different from the day to day structure of school. To have any chance of staffing the program, the numbers of children involved would be too high to allow for social distancing and providing meaningful activities that are safe for children. Furthermore, the complexities of educating our students under the current guidelines is requiring our school district and staff to focus 100 percent on two things: (1) the health and safety of everyone in our schools, and (2) providing your children with an excellent education regardless of how that is delivered. At this time, that needs to be our total focus as a school district and staff.

Along the same lines, to start the 2020-21 school year we will not be able to provide fall extracurricular activities and athletics, including cross country and softball. We will not be able to offer our usual parent-student orientation day or the curriculum nights in person. We are working on plans to share and communicate with virtual orientation and curriculum night presentations. At this time, any events that bring larger groups of people into our schools or that can be avoided or modified will not be held to start the school year.

I think most of you will be very pleased with the thought that has gone into our planning in this regard.

As I shared last week, no plan is going to make everyone happy and we can't promise perfection. But what I can promise is that no one is working harder or in a more thoughtful manner than the wonderful staff here in Cass School District 63.
