Important - New Testing Requirements with COVID Symptoms

In conjunction with guidance from the Illinois Department of Public Health, the DuPage County Health Department is changing an important requirement for testing back in to school after COVID-19 symptoms are exhibited. This is related to Column B under the updated <u>IDPH</u> <u>Exclusion Guidance</u> that our school district follows.

For a symptomatic individual, if the first test is negative and it is an RT-PCR test, the person can return to school (Column B) as long as the symptoms have dissipated. If the first test is negative and is not an RT-PCR test, the DCHD is requiring a confirmatory negative RT-PCR COVID-19 test result within 48 hours following a negative antigen test result or negative rapid molecular (rapid PCR) test result.

To explain this another way, in the absence of a negative RT-PCR test, an individual with COVID-19 symptoms cannot return to school outside of an alternative diagnosis in writing as explained in the exclusion guidance (Column C). A positive test of any kind is considered a confirmed positive and the appropriate 10-day isolation measures are enacted.

To avoid the potential need for two tests, the other option is to pursue the RT-PCR test initially to avoid a "false negative" with one of the other tests. In the absence of confirmatory testing, the student or staff member must complete the minimum 10-day isolation period prior to returning to school. It is also important to note that nothing has changed with the "close contact" requirement, which is still an automatic exclusion for 14 days.

Symptoms? Contact Your Family Physician

Believe me when I tell that you we know this can be very frustrating. We are just passing along the information and the only medical advice that I can provide is to always contact your family physician with ANY symptoms to see what testing is necessary. I would suggest mentioning this guidance from the Illinois Department of Public Health and the DuPage County Health Department when you reach out to your physician.

We expected to see a leveling off in some of our data, and that is exactly what happened this week. The additional wonderful news is that we had another week with no cases or close contacts at school. This is in spite of the higher numbers in our community and region. We are monitoring all of the data carefully but have continued to do well because of our safety measures and protocols here in our schools, as well as the continued vigilance with our parents and staff self-reporting symptoms and close contacts outside of school.

Clarification Regarding Data at School

This is nothing new and not one thing has changed, but I do want to make clear that this does not mean there are no cases in our students or families outside of school. We report ALL cases AT school, as well as ANY close contacts that take place at school. We will also continue to provide any low-risk exposure notifications as a result. These numbers have not changed.

As far as what happens outside of school, we cannot know all of that data for certain. However, what we do know is reported through the "Isolated or Quarantined" lines in the table above. These numbers are the direct result of self-reporting of close contacts, cases and symptoms, as well as any symptoms that may manifest themselves at school. I hope this clarifies and eliminates any confusion, and of course your questions are very welcome.

In-Person Instruction Friday, November 6th

Due to the mandated Election Day holiday earlier this week, this is a reminder that we have inperson instruction for our Tuesday/Thursday students on Friday, November 6th. This also means that we have our normal Monday-Thursday schedule on this day for our students who are fully remote.

Bus Stop Changes

We have hit that point in the school year where we will not be making additional bus stop changes unless it is absolutely necessary. This was one of our greatest challenges with the pandemic and we have remained very flexible for as long as possible, but I wanted to make parents aware of this. We truly appreciate your patience and understanding.

Virtual Parent-Teacher Conferences

This year's parent-teacher conferences will be held virtually via the Zoom platform. Online registration information for Cass Junior High School is included in the NoteTotes and the Concord Elementary School office and teachers are communicating directly with parents regarding conferences. Conferences will be held on Monday, November 23^{rd} from 12:00 - 8:00 p.m. and on Tuesday, November 24^{th} from 8:30 a.m. – 2:00 p.m. As a reminder there is no school for students that week of Thanksgiving when conferences are held.
