They stated that things continue to go well and staff is preparing for the end of the school year.

Superintendent Foderaro discussed the possibility of the continuation of lunch offerings over the summer and the Board of Education discussed options on food programs and the backpack program to share with District families to help them over the summer.

The focus has now shifted to planning for the 2020/21 school year, as the District continues to work with the appropriate authorities in ensuring Cass School District can always meet its number one goal, which is focusing on the safety and welfare for all in the school community.
