# Tuesday, August 16, 2022

Minutes of The Regular Meeting of the Board of Education of Cass School District 63, DuPage County, Illinois; Held at Cass Junior High School at 7:00 P.M. on the 16<sup>th</sup> Day of August, 2022.

## **IV.** Reports, Updates and Informational Items

#### A. Administrative Reports

Dr. Anderson shared that over the summer teachers were working on the new math curriculum and their plans for rolling it out to students at both Concord and Cass. Teachers in kindergarten through 3<sup>rd</sup> grade were trained on Orton Gillingham reading intervention which will now be part of the everyday curriculum in reading for students. Additionally, there was a lot of work done to create the new STEM program at Concord.

Mrs. Marcinkewicz stated that Cass math teachers have also been working hard on the new math curriculum and the 5<sup>th</sup> grade team has been working on math plus which will add an extra 30 minutes of math to the curriculum. Mrs. Marcinkewicz added that she and Assistant Principal Michelle Roberts have also been working on making sure PowerSchool is ready for the new grading system and are working to finalize the bus routes.

Mr. Cross added that everyone from custodians to administrators have been working very hard over the summer to get ready for the 2022-23 school year. Mr. Cross shared that bus routes will be sent out to parents electronically with a link rather than distributed on orientation day. Mr. Cross also shared the district will be rolling out Directory Spot in the fall to share directory information with families. Parents will be given an opportunity to opt out of the directory in advance of the roll out but will also be able to remove information once it is up and running if they choose to do so.

## B. CARE Reports and Grant Funding

Lana Johnson shared that the Ice Cream Social is next Friday and that planning for the return of Trivia Night in October is underway. Dr. Anderson thanked CARE as they have approved a grant for the 4<sup>th</sup> grade students to attend the symphony.

## C. Presentation of the Fiscal Year 2023 Tentative Budget

Mr. Cross presented the fiscal year 2023 budget, which includes an estimated deficit of just over \$375,000. He stated that inflationary increases have impacted the district just like any other business and added that while this is a significant deficit, some of it is also related to the timing of tax payments. Mr. Cross also shared the good news that FY22 ended with a surplus, which he credited to careful and conservative management of expenditures as well as the timing of tax payments that arrived earlier than expected.

The biggest concern for the FY23 budget and beyond is related to how to manage the loss and replacement of the district's HVAC units over time. Mr. Cross emphasized that there are not funds in the budget to handle these types of costs and it would be much better to replace these as part of the long-term plan that the Board has previously developed that will be funded with a successful bond referendum. He said that in the absence of approved funding to finance the Board's plan, other budgetary decisions will have to be made to get the work done, which will impact the education of our students.

D. Update and Discussion Regarding Facility Plans for Safety, Security and Replacement of Heating, Ventilation and Air Conditioning Systems

The Board reviewed the bond resolution and noted that the dollar amount is slightly less than it was the first time and explained the changes and use of grant funds. Mr. Cross reviewed the importance of the community understanding of the life-cycle costs, which take into account the initial cost of the replacement system, expected maintenance costs, energy costs, equipment replacement costs and residual value at the end of a 40-year cycle. He stated that this can be a long term-savings for our local taxpayers, with the geothermal system far less costly. The Board expressed strong support for the plan and the importance of explaining the facts to the community.
